## **OfficerID: Jhenderson**

**On 7/3/16 police observed several subjects with leather vests, upper rocker name " Resurrected", lower rocker Rhode Island and patches with MC, Support "81" and support red and white .Police are familiar with these patches and they are consistent with association with the Hells Angels. Police observed approximately ten (10) white male's in Burnside Park and upon the group seeing a police presence they began walking across Exchange Terrace to the area in front of RI Foundation, 40 Exchange Terrace. Police then approached the (6) motorcycles ( RI motorcycle registration's 15929, 16906, 519, FML13,32019,26524) and conducted an FIR and the subject's were identified as Vincent Green (12/21/61), Keith Collette (6/28/71), David A, Dangelo ((316/58), Richard Amaral (12/4/56), Mark A. Vassallo (10/17/90), Adam Amaral (4/22/84), Thomas D. Hennessey (8/19/90), Kevin M. Manson (9/14/60), Timothy J. Gelinas (5/4/69) and Kenneth L. Newman Jr. (11/20/61). A green Ford pickup truck bearing RI Combination 33463 was parked nearby and is registered to Richard Amaral who has a suspended license. When police asked the group for identification Kenneth L. Newman approached Ptlm. Moody from his blind side and Newman made several movements toward his hip area, then Newman came within the reactionary gap of Ptlm. Moody. Ptlm. Moody made several loud verbal commands for Newman to sit down but he continued forward in a threatening, offensive posture toward Ptlm. Moody. At this time Ptlm. Moody drew his department issued firearm, and using loud verbal commands ordered Newman into a prone position. Ptlm. Moody then reached into a long sheath on Newman's right hip and pulled a knife from the area Newman had been reaching for. Ptlm. Moody held the knife which was legal limit while police conducted the FIR. All ten of the subjects were negative NCIC and local. Several of the subjects attempted to antagonize police during the investigation. Newman stated to police they were doing an initiation for a Prospect in Burnside Park. Car 225 Sgt. Carroll was on scene.**
