On Wednesday May 18, 2016, at approximately 0013hrs., while on routine patrol, Car 333, Patrolman Sheridan observed an unidentified male subject wondering back and forth out of the intersection located in the vicinity of Broad ST. and Montgomery Ave. Police in an attempt to check the well-being of the suspect asked the suspect who he was and where he was going. The suspect replied with "I don't gotta tell you shit!" It was at this time police stepped out of the vehicle and again asked the suspect where he was going the suspect this time pointed over Patrolman Sheridan's shoulder and stated "over there" Police asked what the exact address was to which the unidentified male again stated "I don't gotta tell you shit!" Police then asked the unidentified male to have a seat in the marked cruiser while police figured out where he lived. It was at this time the unidentified male pushed Patrolman Sheridan's arm away and attempted to overpower patrolman Sheridan. It was at this point patrolman Sheridan took hold of the suspects arm and wrist and detained the suspect in the back of the marked cruiser. At this point the suspect began screaming "please don't shoot me GOD please don't shoot me" "the white cop is going to shoot me!" as additional police units arrived on scene the suspect continued to exclaim that he was going to be beat up and killed by "white cops." It should be noted that during the encounter while attempting to gain control and detain the suspect the suspect dented the rear passenger side door of the marked cruiser causing minor damage.

The unidentified suspect was transported to central station where he was held for the next session of 6th District Court. The suspect was charged with simple assault, resisting arrest and Disorderly Conduct. In addition, to those charges the suspect was advised in the Cell Block that if he did not give his personal information he could possibly face an obstruction charge, the suspect stated that he did not care.
